### North Bay Village Application

#### Effective January 15, 2022

An application WILL NOT be considered unless it is completely filled out and submitted with all requested materials and proper fees (which are non-refundable) to North Bay Village Condominium Association, know as NBV, in person, by Fax or by registered mail, Ten (10) days prior to closing or taking up residence at NBV. All parties 18 years of age and older whom are to reside at NBV must apply and sign the application or it will be returned without permission given. A person is not a legal resident or owner until this procedure is completed and approval granted. If a proposed tenant or owner moves into a unit at NBV prior to approval, a \$100.00 fee will be assessed per month up to \$1000.00 per calendar year and the application may be rejected and the tenant or owner may not be approved in the future. Spouses and their children may all be included on one application. Up to two (2) non related residents are allowed on one application and no more than two (2) persons per bedroom.

NBV has restrictions that may affect your lifestyle. It is the responsibility of any resident or owner to acquaint themselves with NBV documents and rules. **All** residents shall go through an orientation interview prior to moving into NBV. This orientation can be especially informative for people planning to purchase as it brings to light many items the purchaser/s should be aware of to make their purchase and future ownership at NBV more pleasant. Please go to NBVINFO.com to review the rules and regulations and our governing condominium documents.

Pleas ensure that the application is legible. Any application that can not be read or understood will not be considered complete.

The following must be included with your application.

- 1) Legible copy of your drivers license or other official government issued photo ID.
- 2) Copy of Social Security card or pay stub with your name and Social Security number on it
- 3) Proof of legal residence or visa if you are not a United States Citizen
- 4) Copy of your proposed lease or purchase and sales agreement.
- 5) Bank certified check, money order made payable to North Bay Village in the proper amount or cash. Application Fees are non-refundable and payable in US dollars.
  - a) \$100.00 per application for purchase or lease
  - b) \$50.00 for transfer of title to another previously registered tenant or owner
  - c) \$50.00 per person for any immediate relative to be added as a resident whom was not on original application.
  - d) Non-US citizen applicants will be charged an additional fee to cover the extra cost of foreign background checks if needed.

The Qualification process requires a Background check. Approval may be affected by the following factors:

- 1) A criminal history which may include events, arrests, a history of incidents that would preclude you from possibly being a good neighbor and living closely to others.
- 2) Incidents of non-payment of rents, foreclosures, evictions.
- 3) False and / or misleading information or statements on your application
